Once a course has been completed, click the link to [Request CE Credit](#). A CE request must be requested within 3 days of course completion. Please note that some states require processing within 10 days, and if you do not comply with this requirement your credits may not be processed. CEU Institute will process the credit and send your certificate generally within 7 – 10 business days after the request is submitted.

****Special Instructions for Florida:** Florida requires students to agree to the Affidavit of Personal Responsibility. "I affirm, under penalty of perjury, that I personally completed the entire text of the self-study course. I also affirm, under penalty of perjury, that I completed the exam without assistance from any source. I understand that it is my responsibility to file or maintain my Certificate of Completion as required by any Department of Financial Services (DFS)." Credit will be reported to the Florida DFS by CEU Institute on behalf of NICTA within 21 days.

*****Special Instructions for Louisiana:** Louisiana requires a student to remain in the course for an amount of time that equals the number of CEs. For example, to get one CE hour the student must remain in the course material 50 minutes, for two CE hours – 100 minutes, etc.

******Special Instructions for Texas:** Licensees may only take up to 50% of their required CE as a self-study course.
