Executive Summary

This ForeCAST Report analyzes motorcycle thefts for 2014 and recoveries for 2014 and 2015 (through 06/30/15) in the United States (U.S.), and the District of Columbia (D.C.). For the purposes of this report, the National Crime Information Center (NCIC) motorcycle theft data for 2014 and recovery data for 2014 and 2015 (through 06/30/15) were analyzed by NCIC Make, Model, and Style fields.

This report is divided into two sections. The first section analyzes motorcycle thefts in the U.S. for 2014 by Theft: year, month, state, city, county, and make. The second section analyzes motorcycle recoveries in the U.S. for 2014 and 2015 (through 06/30/15) by Recovery: year, month, state, and make. The appendix at the end of this report includes the methodology of the data editing.

Overall, there were a total of 42,856 motorcycle thefts in the U.S. in 2014. From 2013 to 2014, motorcycle thefts decreased 6% even though motorcycle sales increased. According to the Motorcycle Industry Council¹ (MIC), there was a 4% increase in motorcycle sales between 2013 (465,783) and 2014 (483,526); a difference of 17,743 units.

Motorcycle thefts occur more frequently in the warmer months, where August and July had the most motorcycle thefts, while February and January had less frequent thefts. Motorcycle thefts were highest in the state of California (6,355) in 2014. The District of Columbia (DC) had the largest percent increase (54%) in motorcycle thefts from 2013 to 2014, while Wyoming had the largest percent decrease (-43%) in motorcycle thefts from 2013 to 2014. Analysis by city found Las Vegas, NV to have the highest count of thefts (1,163) in 2014, a 29% increase over 2013.

There were 1,973 U.S. counties identified in 2014 with a motorcycle theft. The top 25 counties accounted for 31% of motorcycle thefts in 2014, with Clark, NV ranking 1st. The highest county rate² of motorcycle theft in 2014 was Fairfax City, VA (41.3). Motorcycle thefts for 2013 – 2014 had substantial change in counts for 31 counties with greater than 3 standard deviations from the mean. Additionally, motorcycle thefts for 2013 – 2014 had substantial change in rates (per 10k) for 23 counties with greater than 3 standard deviations from the mean.

Analysis found Honda to be the manufacturer with the most thefts (8,045) in 2014. Manufacturer Jonway Group had the highest percent change (35%) for 2013 – 2014 motorcycle thefts.

Of the 42,856 motorcycle thefts in 2014, 17,757 or 41% of the motorcycles were recovered from 01/01/2014 through 06/30/2015. In 2014, August (1,960) and July (1,941) were months with the largest number of


motorcycle recoveries while January (407) and February (495) had the fewest motorcycle recoveries. In 2014, California had the most (2,764) recoveries statewide. The highest rate of recovery (40%) for top 10 theft states was in Nevada for 2014. Analysis found Honda to be the manufacturer with the most (3,368) recoveries in 2014. Manufacturer Triumph had the highest rate (67%) of recovery in 2014.

SECTION 1: Motorcycle Thefts in the U.S. 2014

This section analyzes the 42,856 motorcycle thefts which were reported to NCIC, in the U.S. in 2014. The following subsections further analyze the 42,856 motorcycle thefts by: theft: year, month, state, city, county, make, and motorcycle year.

Motorcycle Thefts: By Year

The following graph shows the comparison of reported motorcycle thefts in the U.S. for the theft years of 2011 through 2014. The number of motorcycle thefts declined by 1% from 46,667 units³ in 2011 to 46,061 units⁴ in 2012. The number of motorcycle thefts declined 2% from 46,061 units in 2012 to 45,367 units⁵ in 2013. The number of motorcycle thefts declined 6% from 45,367 units in 2013 to 42,856 units in 2014. Overall, motorcycle thefts declined by 8% from 2011 through 2014.

Motorcycle Thefts: By Month


The following tables and bar graph illustrate motorcycle thefts in the U.S. by the month, percent, rank, and quarter. In general, motorcycle thefts are seen as a seasonal crime related to warmer months where months with 10% or more thefts from the yearly total occurred in May, June, July, August, September, and October. Months with 6% or less of the year's total thefts occur in the winter months of December, January, February, and March. Theft count ranks highest (1st) in the month of August, with July ranking 2nd, and June coming in 3rd. The 3rd Quarter has the highest theft counts at 14,246 while the 1st Quarter had the lowest theft counts at 6,995. In 2014, motorcycle thefts had a higher count in December compared to motorcycle thefts occurring in the same month in 2013.

Motorcycle Thefts: By State

The following table shows the number of 2014 motorcycle thefts in the U.S. by theft state. The chart breaks down each state by monthly quarters as well as ranks each state by total number of motorcycle thefts. The chart further shows the percent of total U.S. thefts by state. There were a total of 42,856 thefts in the U.S. in 2014 with the top 10 states of California, Florida, Texas, South Carolina, North Carolina, New York, Indiana, Nevada, Georgia, and Maryland accounting for over 58% of the total U.S. thefts in 2014.



The following graph shows the top 10 states with the largest number of motorcycle thefts in the U.S. for 2014 compared to theft counts for 2013⁶. Three (3) of the top 10 states saw an increase in motorcycle theft in 2014 and 7 of the top 10 states saw a decrease in motorcycle theft. Of the top 10 states, Florida had the largest increase (246) in motorcycle thefts and Indiana had the largest decrease (691) in motorcycle theft in 2014.




The following map shows the distribution of motorcycle theft across the U.S. by state.

The following table shows the percent change of motorcycle thefts between 2013 and 2014 in the U.S. by theft state. The chart breaks down the states into 2 categories; states with increased thefts between 2013 and 2014, and decreased thefts between 2013 and 2014. The chart ranks each state in its respective category. There are 16 states that saw an increase in the number of motorcycle thefts in 2014 compared to 2013, with DC having the highest increase (54%). There are 35 states that saw a decrease in the number of motorcycle thefts in 2014 compared to 2013, with Wyoming having the highest decrease (-43%). An asterisk (*) represents a tie in the state percent change rank.

Motorcycle Thefts: By City

The following table shows the top 15 cities in the U.S., listed by 2014 theft count. There were 42,865 motorcycle thefts in the U.S. in 2014. The top 15 cities accounted for 7,523 motorcycle thefts in 2014, an increase of 263 motorcycle thefts from 7,260 top 15 city motorcycle thefts in 2013. Of the top 15 cities, 7 had an increase in motorcycle theft in 2014 with Albuquerque, NM listing the largest increase (36%) followed by San Francisco, CA in 2nd (34%), and Las Vegas, NV in 3rd (29%). Five (5) cities listed a decrease in motorcycle theft in 2014 with Los Angeles, CA and Indianapolis, IN listing the largest change (-27%).



Motorcycle Thefts: By County Count

There were a total of 1,973 U.S. counties⁷ identified as having a motorcycle theft occur in 2014. In 2013, a total of 2,060 U.S. counties were identified as having motorcycle thefts. There were 87 less counties in 2014 that had motorcycle thefts compared to 2013. Further analysis of the 2 years revealed that 304 of the 1,973 counties in 2014 had no motorcycle thefts in 2013.

The following table displays the top 25 counties, in 2014, with motorcycle thefts. The top 25 counties accounted for 13,328 thefts or 31% of the 42,856 motorcycle thefts in 2014. Clark County was determined to have the highest count of thefts; 1,308 in 2014. The table lists the top 25 counties, 2013 theft counts, percent change between 2013 and 2014, and the percent change between 2012 and 2014. Of the top 25 counties, 14 saw an increase in motorcycle theft between 2013 and 2014 while 11 saw a decrease. Of those 14 counties that saw an increase, 10 saw increases in percent change between 2013 – 2014, and 2012 – 2014. The table also lists each counties rate⁸ of motorcycle theft per 10,000 people, based on the 2013 U.S. Census population.



The following table shows a list of counties in the U.S. between 2013 and 2014 motorcycle theft count change per county, by standard deviation¹⁰. Thirty-one (31) counties are greater than 3 standard deviations from the mean, all of which had a substantial changes in motorcycle thefts between 2013 and 2014. Of the 31 counties, 13 counties had substantial increases in motorcycle thefts between 2013 and 2014 and are greater than 3 standard deviations from the mean. The remaining 18 counties had substantial decreases in motorcycle thefts between 2013 and 2014 and are greater than 3 standard deviations from the mean. The remaining 18 counties had substantial decreases in motorcycle thefts between 2013 and 2014 and greater than 3 standard deviations from the mean. Additionally, thefts from 2012



Motorcycle Thefts: By County Rate

The following table shows a list the top 25¹² theft rate counties in the U.S. for 2014 motorcycle thefts based by their rate of theft. The table is listed according to rate of theft rank per 10,000 people in the county (listed on left) and also shows each counties theft count (listed on right). Additionally the table lists 2013 motorcycle theft rate, 2013 – 2014 theft rate percent change, and 2014 theft count. Of the 1,973 U.S. counties identified as having motorcycle thefts occurring in 2014 Fairfax City County, VA was identified (3rd consecutive year) as having the highest theft rate per 10,000 people, followed by Horry County, SC. The top 25 theft rate counties listed below account for 6,083 thefts or 14% of the total 42,856 motorcycle thefts in 2013. Of the top 25 theft rate counties, 17 saw an increase in theft rate, 7 saw a decrease in theft rate, and 1 county saw no change in rate between 2013 and 2014. An asterisk (*) represents a tie in theft rate rank.




Motorcycle Thefts: By Make

There were a total of 473 motorcycle¹⁴ makes identified within the 42,856 motorcycle thefts in the U.S. in 2014. The following table displays the top 15 makes with motorcycle thefts in 2014. The top 15 makes accounted for 34,970 of the total 42,856 thefts in 2014 or about 82%. Honda accounted for the most thefts in 2014 with 8,045 motorcycle thefts, with Yamaha 2nd, and Suzuki 3rd. Of the top 15 makes, 5 had a decline in the reported number of thefts in 2014 compared to 2013. Suzuki and Honda listed the highest decrease (-6%) in motorcycle thefts in 2014. The remaining 10 of the top 15 makes had increased in the number of thefts in 2014 compared to 2013. Jonway Group listed the highest increase in the number of motorcycle thefts (53%) in 2014.

SECTION 2: Motorcycle Recoveries in the U.S. (2014 through 06/30/15)


This section analyzes the 2014 U.S. motorcycle thefts recovered between 01/01/2014 and 06/30/2015. There were 17,757 motorcycle recoveries associated with the 42,856 motorcycle thefts in the U.S. for 01/01/2014 through 12/31/2014. Of the 17,757 motorcycle recoveries, 15,206 recoveries occurred between 01/01/2014 and 12/31/2014 and 2,551 were between 01/01/2015 and 06/30/2015. The following subsections further analyze these 17,757 motorcycle recoveries by: year, month, state, and motorcycle make.

Motorcycle Recoveries: By Year

The pie chart shows the recovery rate, which was 41% for the 2014 motorcycle thefts recovered in 2014 through 06/30/2015. Looking at individual year recoveries for 2014 and 2013 the table shows there was a 1% decrease or 225 less recoveries for a total of 15,206 motorcycles recovered in the year 2014 compared to 15,431 in 2013¹⁵.

Motorcycle Recoveries: 2014 through 06/30/15


The following chart shows the number of motorcycle recoveries by month from 2014 through 06/30/2015. The chart is analyzed by months and years. The highest recovery occurred in August with 1,960 recoveries and followed by July with 1,941 recoveries as well, August and July had the greatest number of thefts. The months with the fewest number of motorcycle recoveries in 2014 were January (407) and February (495).

Motorcycle Recoveries: By State

The graph below shows the top 10 states for motorcycles stolen in 2014 and recovered between 2014 through 06/30/2015. The top 10 states accounted for 9,787 motorcycle recoveries, or 55%. The state with the most motorcycle recoveries was California with 2,764 motorcycle recoveries, or 16% of the 17,757 motorcycle recoveries between 01/01/2014 and 06/30/2015.



The following table displays the number of recoveries for 2014 through 06/30/2015 by recovery state. The chart is analyzed by year and then is ranked by total number of recoveries from 2014 through 06/30/15. Five hundred and thirty nine (539) recoveries, or 3% did not identify a state and were therefore not listed on this table. Additionally, the table lists rate of recovery for the 2014 thefts vs 2014 recoveries only.





Motorcycle Recoveries: By Make


A total of 331 motorcycle makes were identified from the 17,757 motorcycle recoveries in the U.S. from 2014 through 06/30/2015. The following table and graph displays the top 15 makes of motorcycle recoveries. The top 15 makes accounted for 14,246 motorcycle recoveries, or 80% of the 17,757 motorcycle recoveries. The make with the most recoveries was Honda which accounted for 19% of the total motorcycle recoveries. Of the top 15 makes, Triumph had the highest rate of recovery at 67%.

Appendix A: Motorcycle Theft

The NCIC theft data from 2014 was edited in the following manner:

• Records with thefts of anything other than motorcycle models were removed.

• Records with blank or incomplete VIN fields were removed.

• Records with motorcycle parts (wheels, tracks, etc.) were removed.

• ATVs, watercraft, golf carts, motorized wheelchairs, snowmobiles, toys, go-carts, farm equipment, etc. that were mislabeled as a motorcycle style were removed.

• VIN structures that began with "ATV" were removed.
