



# COVID-19 Stay at Home Orders

A majority of the U.S. population resides under a government Stay at Home order, as states and local governments fight to flatten the curve against COVID-19. The charts below provide a detailed list of the orders issued by states, counties, and cities. However, as state and local governments are acting fast the charts may be missing a few orders.

At this time 27 states, 49 counties, and 13 cities have issued Stay at Home Orders.
